That the Defendant, on or about the 30TH Day of December, 2004, did then and there intentionally or knowingly threaten to harm another, to wit: [REDACTED] by an unlawful act in retaliation for or on account of the service or status of the said [REDACTED] as a witness or prospective witness, said unlawful act being a threat to terminate [REDACTED] from her employment at Agape Christian Fellowship Church and said threat was communicated to [REDACTED] in person.

That the Defendant, on or about the 28TH Day of January, 2001, in Tarrant County, Texas, engaged in Improper Sexual Contact against [REDACTED]

That the Defendant, on or about the 18TH Day of November, 2004, in Tarrant County, Texas, did attempt to obtain information about what transpired in the Grand Jury from [REDACTED] and said information by law is secret, and [REDACTED] had taken an oath to keep said information secret.

XXVI.

That the Defendant, on or about the 15TH Day of May, 2004, in Tarrant or Dallas County, Texas, did commit the offense of Assault against [REDACTED]

XXVII.

That the Defendant did make routine threats that he was connected to people who could harm anyone on his command.

XXXIII.

That the Defendant, on or about the 15TH Day of December, 2003, and up to the present, in Tarrant County, Texas, did fraudulently represent and hold himself out to others to be Terry Lee (First Name, Last Name), when actually the Defendant's true name is Terry Lee Hornbuckle.

XXXIV.

That the Defendant, on or about the 15TH Day of December, 2003, and up to the present, in Tarrant County, Texas, and/or Dallas County, Texas, and/or Denton County, Texas, did fraudulently represent and hold himself out to others to be a member or a former member of the Dallas Cowboys, the Washington Redskins, and the University of Texas football teams.

XXXV.

That the Defendant, on or about the 15TH Day of December, 2003, and up to the present, in Tarrant County, Texas, and/or Dallas County, Texas, and/or Denton County, Texas, did fraudulently represent and hold himself out to others to be the spiritual adviser for the Dallas Cowboys professional football team.

XXXVI.

That the Defendant, on or about the 27TH Day of July, 2003, in Tarrant County, Texas, did commit the offense of Sexual Assault against [REDACTED], and did not inform [REDACTED] that he had a sexually transmitted disease, namely Herpes.

XXXVII.

That the Defendant, on or about the 31ST Day of July, 2004, in Tarrant County, Texas, did commit the offense of Sexual Assault against [REDACTED] and did not inform [REDACTED] that he had a sexually transmitted disease, namely Herpes.

XXXVIII.

That the Defendant, on or about the 1ST Day of February, 2002, in Tarrant County, Texas, did commit the offense of Sexual Assault against Jane Doe (A pseudonym), and did not inform Jane Doe (A pseudonym) that he had a sexually transmitted disease, namely Herpes.

XXXIX.

That the Defendant, on or about the 1ST Day of September, 2004, in Tarrant County, Texas, did commit the offense of Sexual Assault against Kate Jones (A pseudonym), and did not inform Kate Jones (A pseudonym) that he had a sexually transmitted disease, namely Herpes.




